This bulletin is issued to modify/amend items in the Bidding Documents. This shall form an integral part of the Bidding Documents, to wit:

This document addresses the clarifications on the specifications of the **Supply and Materials for Construction of NEECO II AREA2 Branch Offices (PALAYAN CITY & GABALDON) (LOT B & C)**, during the Pre-Bid Conference on January 20, 2026 at the NEECO II – Area 2 Main Office.

Main Concerns:

1. Clarification on Eligibility Requirement
 - 1.1 Under Eligibility Requirements, Folder 2 – Envelope I, Item B.2, the required license for infrastructure projects is hereby clarified and specified as follows:
 - 1.1.1 PCAB License For infrastructure projects, bidders must possess a valid and current Philippine Contractors Accreditation Board (PCAB) License with the appropriate classification, specifically: Classification B General Building - Building and Industrial Plant, suitable to the scope of work and contract cost of the project
2. Authorization to Represent the Company To ensure proper authority and accountability in the bidding and project implementation, the following documents are hereby required and clarified:
 - 2.1 Secretary's Certificate Corporations and cooperatives must submit a Secretary's Certificate issued by the Corporate/Board Secretary, authorizing the designated representative to:
 - 2.1.1 Participate in the bidding process Sign bidding documents, including the Omnibus Sworn Statement Represent the company during all stages of the procurement process
 - 2.2 Special Power of Attorney (SPA):
 - 2.2.1 If the authorized representative is not a corporate officer, a Special Power of Attorney (SPA) shall be submitted, clearly authorizing the representative to: Act on behalf of the company in the bidding procedure Represent the company during project implementation, if awarded,
 - 2.2.2 Failure to submit the appropriate Secretary's Certificate and/or SPA, as applicable, shall render the bid non-responsive.
3. Effectivity This Supplemental Bid Bulletin shall form an integral part of the Bidding Documents and shall be binding on all prospective bidders.

This document addresses the clarifications on the specifications of the **Supply and Delivery of Tools and Equipments for NEECO II AREA 2 (Lineman Tools & Equipments) (Lot D & E)** during the Pre-Bid Conference on January 20, 2026 at the NEECO II – Area 2 Main Office.

Main Concerns:


1. Clarification on Eligibility Requirements (Envelope 1) For bidding conducted on a per-item or per-lot basis, the following rules for documentation shall apply:

- 1.1 Consolidated Submission: Bidders participating in multiple items/lots may submit one (1) set of eligibility documents in Envelope 1.

- 1.1.1 Statement of All Ongoing Contracts (Section 1.a): Bidders must list all ongoing government and private contracts. This remains a requirement to determine the bidder's capacity.

- 1.1.2 Single Largest Completed Contract (SLCC) (Section 1.b): The bidder must identify an SLCC that is "similar in nature" to the items being bid. The amount of the SLCC must be at least 50% of the ABC of the item/lot with the highest value among all those the bidder is participating in.

2. **Reminders for Bidders: The Opening of Bids remains scheduled for February 3, 2026. Ensure that the SLCC is supported by an End-User's Acceptance or an Official Receipt to avoid a "non-responsive" rating during the preliminary examination of bids.**
